1. **Apologies:** Cllrs Markham, Burroughes, Hurlock, Hall and Poulter
2. **Declarations of Interest and dispensations:** No declarations were made for matters on the agenda.
3. **To consider confirming the Minutes:** The minutes of the Annual Parish Council Meeting of 11th May 2022 were confirmed and signed.

4. Public forum

The matter of improvements to access to the Petanque court were discussed. The court does not currently appear accessible because of precautions to be taken to prevent damage by wildlife.

A recommendation was made to create a paved area around the court with fencing a gate to provide access.

All present were in agreement that the Parish council could look to provide financial support (in conjunction with the trustees of the village hall) for this endeavour and a quote was requested in order to proceed.

8.3. **DC/22/2432/CON | Land Off The Street Hacheston Suffolk IP13 0DT** – moving an electrical post to and H post to “allow development of the site”. The application was originally for the formation of a farm access. The parish council remain against the development of the land and continue to oppose this application.

Action: Sarah Mott to write to local planners stating that the parish council does not support this proposal, referring back to the earlier planning application that contains our statement. The Concerns raised at this time remain valid. Attention should also be drawn to the lack of plan.
